Purpose: An open Regulatory Conference will be held at Entergy's request to provide the licensee an opportunity to present to the NRC its perspective on the facts and assumptions the NRC used to arrive at and assess the significance of the preliminary "Greater-Than-Green" finding and associated apparent violation documented in NRC Inspection Report No. 05000293/2015007, dated May 10, 2017, (ML17129A217), (EA-17-023), "Pilgrim Nuclear Power Station" – Supplemental Inspection Report (Inspection Procedure 95003 Phase 'C') and Preliminary Greater-Than-Green finding.

The finding is related to Entergy's failure, in May 2000, to account for potential new failure mechanisms on a new component, a relief valve, on the right-angle drive for the 'A' emergency diesel generator radiator blower fan. As a result, Entergy did not consider the need to periodically monitor or maintain the valve, which subsequently failed, as identified by Entergy on September 28, 2016, resulting in the 'A' emergency diesel generator having been inoperable for a period greater than its technical specification-allowed outage time. This conference will also address whether enforcement action is warranted for the apparent violation of NRC requirements [Title 10 of the *Code of Federal Regulations* (10 CFR) Part 50, Appendix B, Criterion III, "Design Control"] associated with the preliminary "Greater-Than-Green" finding.

Category: This is a Category 1 Meeting. Following the business portion of the meeting, members of the public will have an opportunity to discuss Entergy's performance and the role of the NRC in ensuring safe operations at the plants. The agenda is enclosed.


